However, you can vote your shares before the Meeting by returning the enclosed voting instruction form ("**VIF**"), voting online or using the toll-free telephone number set out on the VIF prior to the date set out therein, in accordance with the instructions provided by your broker or other intermediary. Notice-and-Access

The Corporation has elected to use "notice-and-access" rules ("**Notice-and-Access**") under National Instrument 54-101 *Communication with Beneficial Owners of Securities of a Reporting Issuer* ("**NI 54-101**") for distribution of its Proxy-Related Materials (as defined below) to shareholders who do not hold shares of the Corporation in their own names ("**Beneficial Shareholders**"). Notice-and-Access is a set of rules that allows issuers to post electronic versions of proxy-related materials on SEDAR+ and on one additional website, rather than mailing paper copies. "**Proxy-Related Materials**" refers to the Circular, the Notice of Meeting, a VIF and a form of proxy.
